## For what purpose do we process your personal data?

At the Forest Ownership Centre we process the information facilitated by interested parties in order to organise their enrolment in seminars they wish to attend.

At no time are these data used for commercial profiling or automated decision-making.

## How long do we retain your data?

The personal data you provide shall be retained until a response is issued to your query.

## What is the legitimacy of the processing of your data?

The legal basis for the processing of your data is the issuance of your consent as a data subject, which starts when you send the contact query.

## To which recipients are your data communicated?

The data are not communicated to any third parties, including third countries or entities, unless there is a legal requirement to do so.

## What are your rights?

You have the right to obtain confirmation of whether or not we at the Forest Ownership Centre are processing personal concerning you.

Data subjects have the right to access their personal data and request the rectification of inaccurate data or, where applicable, request their erasure, among other reasons, when the data are no longer necessary for the purposes for which they were collected.

In certain circumstances provided for in article 18 of the GDPR data subjects may request the restriction of the processing of their data. In this case we will only retain them to exercise or defend legal claims.

Data subjects may oppose the processing of their data for direct marketing purposes, including profiling. The Forest Ownership Centre shall cease processing the data except in the case of compelling legitimate interests or to exercise or defend possible legal claims.

By virtue of the right of portability, interested parties have the right to obtain their personal data in a structured, commonly used and machine-readable format and transmit them to another controller.
